Terms and Conditions

These Terms and Conditions are for QS Learning in-centre and online courses, which incorporate by reference to all our Terms and Conditions. Please read the following Terms and Conditions carefully before joining the in-centre and online courses and print off a copy for your records. By joining our courses, you are confirming your agreement to be bound by the QS Learning terms and conditions.

Please read both sections of the Terms and Conditions fully.

In-Centre Tutoring

Opening Hours

QS Learning has standard opening hours of 4pm to 6.00pm, Monday and Wednesday, 10:00am to 12:00pm Saturday and 12:30pm to 2:30pm Saturday. QS Learning will be closed during the Christmas break and the Easter break as well as a few staff training days. We operate as normal on Bank Holidays, Half Term and the Summer Holidays.

Drop-off and Collections

Drop-off can be agreed for 4:00pm on Monday and Wednesday, and 10:00am or 12:30pm on Saturday.

It is the parents' responsibility to bring their child into the centre before their session and to collect them from the centre at the end of their session. Children should not leave the building under any circumstances unless accompanied by a responsible adult. Children will only be allowed to walk home alone if we have written consent from the parents.

Children should be collected promptly at the end of a session. Any parent who is unable to collect at the correct time needs to inform the centre manager immediately to allow us to staff the centre accordingly. If you collect your child more than 10 minutes late, there will be an additional charge of £40.

If parents are unable to pick up their child from the centre, they must ensure that proper arrangements are made and that we are provided with a name or names of persons authorised to collect the child/children. Ideally, this person should be introduced to the centre manager. We cannot release a child to someone we do not know to be authorised.

Payments

All monthly payments are collected through recurring payments on the 20th of each month for the following month. Any payments received after the 20th will incur a £40 charge. We use a secure third party service provider to collect payments. Please note we do not provide refunds under any circumstances. Student breaks/holidays/ time off is offered in August only. Monthly payments have to be made throughout the year.

Student break or holiday time off is offered in August only. Monthly payments have to be made throughout the year. Students will be offered catchup lessons for face to face group or one to one lessons.

Additional charges

Any additional charges e.g. extra sessions, late pickup charges, late payment fees and excursion charges will be added to your subsequent month's invoice.

Loss of your place at QS Learning

QS Learning reserves the right to terminate your child's place at the centre in the event that any fees remain unpaid or if you fail to give us 4 weeks written notice period prior to leaving our services. We will under no circumstances be able to offer your child any current sessions that have been paid for and will withdraw your child from their course with immediate effect. If you behave in an unacceptable manner towards staff, children or customers of the centre, where any of the terms and conditions are breached a termination of your child's place will be considered to be in the best interests of the centre.

Fees

Fees are reviewed regularly. If any charges are deemed necessary, parents are given four weeks' notice. Fees must be cleared in advance in full each month.

Admission

Places are allocated on a first-come, first-served basis.

Registration and Enrolment

After your initial enquiry your child will be invited to the centre to do a free initial assessment. There is a non-refundable registration and administration fee that has to be paid for each new admission. Once we have received this, your child will be placed on the enrolment list and you will be informed of the start date once the first monthly payment has been cleared.

Deposit

To secure a place at the QS Learning Centre there is a four week fee, payable immediately, (based on the sessional attendance you are booking for your child). If you have confirmed with the centre that a place is available for your child, the fee must be paid in order to secure your child's place. If a place is not available when you are registering your child, you need only pay the registration fee and your child will be placed on the waiting list. Once we have accepted your fee, and you have completed the admission form, your child's place is guaranteed.

If the child does not attend the centre once the place has been accepted, the fee is non-refundable.

Once your child has started at QS Learning, if you wish to leave the centre, we require four weeks' notice (in writing).

Security Deposit

QS Learning has the right to demand deposit (equivalent to one month's fee) at the time of admission. This will be in addition to the registration fee as well as the monthly fee. This will be reflected on the first invoice sent to you when joining QS Learning.

Initial invoice

The first invoice sent to you would include the registration fee, one month's deposit as well as the first month's fee. If you join us on or after the 15th of the month you will be invoiced for 6 weeks. If you join us between the 1st and the 14th of the month you will be invoiced for 4 weeks. Please note that we cannot offer invoice and payment flexibility for less than 4 weeks each month.

Basis of fee calculation

Fees are calculated on a monthly basis (28 days month) according to the sessional attendance of your child. We usually invoice every 4 weeks. Refunds or deductions cannot be made if your child is ill; on holiday or for any other reason the child does not attend the centre.

Payment terms

All monthly payments are collected through recurring payments on the 20th of each month for the following month. Any payments received after the 20th will incur a £30 charge. Please note we do not provide refunds under any circumstances. Invoices are issued by the 15th of each month for the following month and fees must be paid in full by the 20th of each month.

Sibling discount

A sibling discount is available where three or more of the siblings are attending one of the courses at QS Learning centre. The discount is subject to variation depending on the number of siblings attending the centre. The siblings must attend the same number of hours for the discount to be valid. Any variation in the number of hours for the children means that a sibling discount will not be valid.

The sibling discount will only be valid when three or more siblings attend the centre regularly. In the event where one sibling leaves the centre, the sibling discount will not be valid from the day the sibling leaves the centre and the full fee would be payable.

Sibling discount is only available on a limited number of courses. Please enquire within for further details.

The sibling discount is only valid for siblings, cousins and other family members will not be considered under the sibling discount.

Refer a friend scheme

To be eligible for the refer a friend scheme, the referred student must be attedning and regulary paying the fee for the courses at QS Learning and must not have any outstanding debts with QS Learning. Child care vouchers

Free sessions

From time to time we offer free sessions. Where a free session is offered, it cannot be exchanged, swapped or rescheduled. A free session can only be availed at the time is it offered.

Extra sessions

Extra sessions are available at a certain discounted price. If you feel that your child needs extra sessions please speak to the centre manager for further information.

Changes in hours

Changes in tutoring hours will change the monthly fee price.

Termination of tuition

We require a one month's (4 weeks) written notice if you wish to terminate tuition at QS Learning. This is assuming that the notice has been given at the beginning of the month. We reserve the right to charge for any unpaid sessions in the event of the termination of the tuition. Further details are available via the centre manager.

Materials

Key Stage 1, 2 & 3

QS Learning provides the children with the relevant material for their learning to take place effectively. Children are welcome to bring in their own note books and stationary but the centre does not take any responsibility of any damages or losses.

11 plus, GCSE and A-levels

QS Learning provides some of the material for the students enrolled onto these programmes. Parents will be expected to purchase the suggested materials for the preparation of their child's course.

Books

Students are responsible for arranging their own books to use at home. We provide reading books, text books, exam papers etc to be used at the centre only. We take no responsibility for the purchases of any books required outside the centre.

Absences/Illnesses

If your child will not be coming to the centre for any reason, please let the staff know as soon as possible on 0208 144 4149. If you fail to inform us we will be unable to re-book a replacement session for your child and the fee will still be deducted for the missed session.

Please do not send your child to the centre if they are unwell. If your child is unwell please keep them at home until your Doctor confirms that any risks of infection have gone. In the case of sickness this would be a period of 48 hours after the last attack. The centre reserves the right to request that children be collected if it is felt in any way that they are not well enough to attend. The student will not be offered a replacement session.

The centre cannot administer medicines.

We reserve the right to administer basic first aid treatment where necessary. Parents will be informed of all accidents and will be required to sign an accident form.

In case of emergency we will seek appropriate medical treatment and will inform the parent/guardian as soon as possible.

Catch up sessions

Catch up sessions for all **informed** missed sessions can be arranged in agreement with the centre manager. Catch up sessions can only be provided within the time period where the full fee has been paid for regular sessions and all previous payments are up to date. Catch up sessions are considered separate from the regular sessions and cannot be swapped, replaced or exchanged by regular sessions.

Personal effects

Children should not bring toys, jewellery, money or other valuables to the Centre, as the Centre cannot accept responsibility for these.

The Centre accepts no responsibility for loss or damaged items.

Some children studying at QS Learning Centre are very young and so we are happy for the child to bring water to be consumed on the premises. Water is present at the premises. No chocolate, sweets or other types of snack food are to be brought to the Centre. It is our policy to ban ANY kind of chewing gum being brought into the building by pupils.

Glasses/Hearing Aids

Switching between methods of learning

Obligation of parents/guardians

You undertake to notify the centre of (for example but not limited to) any medical or educational situations where special arrangements may be needed to your child. Switching between methods of learning
